### New Clean Energy Legislation

In 2012, New Jersey passed legislation (P.L. 2011, Ch. 187) enabling Property Assessed Clean Energy or “PACE”, a game-changing financing model for energy retrofits and renewable energy systems for commercial, industrial, and nonprofit buildings. Up to 100% financing is made available for approved projects, and repaid according to the terms of a Special Clean Energy Assessment registered with the municipality. PACE financing:

1. Saves property owners money on their energy bills and improves property value
2. Creates jobs and economic development
3. Conserves energy and reduces carbon pollution
